ENTRY DEADLINES AND FEES:

ENTRY DEADLINE – APRIL 19th (postmarked on or before) *PAPER ENTRIES ONLY*

ENTRY FEE - \$4.00 PER RABBIT / \$2.00 FUR CLASSES

SHOW RULES:

1. All rabbits must be checked in by **7:30 AM** in the **Arkansas Building**.
2. No changes or substitutions will be made after 7:30 AM. **Books will close at 7:30 AM.**
3. This is a **youth only** carrier show - All rabbits entered must be handled by youth.
3. **ELIGIBILITY:** This division is limited to Arkansas students only, who are bona fide members of an Arkansas FFA Chapter or 4-H Club in good standing. Exhibitors must be at least nine years of age by the opening day of the current year's fair (October 8, 2010). Exhibitor's project program must be under the supervision of a Vocational Agriculture teacher or a County Extension Agent. Exhibitors will represent the youth organization whose agent or instructor signs Box #2 of the Exhibitor Signature Form. Exhibitors must have a Livestock Exhibitor's Signature Form on file in the ASF Livestock Office. The organization represented must be the same for all species in which the exhibitor has entries. **Exhibitors may exhibit in this show no later than the fall after graduating from high school or having received a GED certificate.** Junior Exhibitors displaced due to transfer or assignment of a parent/guardian on active duty with the U.S. Armed Forces and is ineligible to show at new location, may be eligible to participate as a Junior Exhibitor for that one show year. Membership/ representation must remain with that of prior show year. **Contact Arkansas State Fair Livestock Department for clarification and approval.**
4. All rabbits must be entered in the name of the bona fide owner.
5. **All rabbits** must be **permanently and legibly ear marked** in the rabbit's left ear or they will be **disqualified**.
6. Exhibitors must pick up their own ribbons. Premiums and legs will be mailed at a later date.
7. Any animal showing signs of illness or disease will be removed from the showroom.
8. This is an ARBA Sanctioned Show and will be governed by the latest ARBA Show Rules for a Fair Show.

AWARDS:

- Entry Fees will be Jackpotted for premiums. Premiums will be paid through 3rd place.
- Ribbons for 1st to 10th place. Banners for Best in Show, Rosettes 1st – 4th runner up. Meat Pen & Single Fryer will have Grand and Reserve Grand awards.
- Awards will be provided for all Best of Breeds, Best Opposite Sex of Breed and Best Rabbit in Show.
